



Michigan's COVID-19 Eviction Diversion Program

What it is

The Eviction Diversion Program (EDP) was created to keep Michigan residents who fell behind on their rent during COVID-19 in their homes. Eligible tenants can receive financial help to get caught up on their rent.

How it works

The Michigan State Housing Development Authority (MSHDA) is giving funding to homeless service providers called Housing Assessment and Resource Agencies (HARAs) in each county to provide rental assistance to eligible tenants facing eviction for non-payment of rent.

What you should do

If you are behind on your rent and receive a **Notice to Quit** or **Demand for Possession**, or if you have been served with a **Complaint for Eviction** for nonpayment of rent -

- 1 Contact your local HARA to apply for assistance (see next page)
- 2 Check with your HARA to find out the best way to send in your completed application and supporting documents
